APPLICATION COMPONENTS

- Bachelor's degree or U.S. equivalent
- Online application
- Essays
- Transcripts
- Resume
- Proof of English Language Proficiency (TOEFL, IELTS, or Duolingo scores) is required if the bachelor's degree was not conducted in English
- \$85 application fee

Applicants who will need an F-1 or J-1 student visa to study are not eligible to apply due to constraints relevant to US immigration regulations.
